PEP BASICS

How Do I Register?

- Find classes at www.ctfsa.org
- Contact the agency most convenient for you for information about registration and fee arrangements
- Be sure to tell the provider if you must complete the class by a certain date
- Complete Section 2 of the Parenting Education Program - Order, Certificate, and Results form (JD-FM-149) and bring your completed forms with you to class
- Upon satisfactory completion of the program, the program provider will send you and the court a certificate of completion

How Much Does It Cost?

- The cost is \$150 per person
- You must pay the agency directly. The fee is not paid to the court. In cases in which the parent cannot afford the fee, the court may grant a fee waiver

How Long Is the Program?

• The program is available in one 6-hour session or two 3-hour sessions





WHAT IS PEP?



The **Parenting Education Program**, or PEP, is a mandatory 6-hour parenting education program for any parents with children under the age of 18 who are involved in court proceedings in family relation matters. The focus of the program is to provide relevant material regarding the impact of family restructuring on children during times of separation and divorce.

Any change in family dynamics will affect all members of your family unit, children often being the most vulnerable. This program is designed to help support and prepare you to *co-parent* and to place your children's needs at the forefront of all your decisions. PEP is focused on improving communication in order to decrease conflict and feelings of ill will within your family throughout, and long after, the separation or divorce process.

Your PEP Facilitator

Your PEP Facilitator is experienced in child development and behavioral health and trained to guide you through the class. The facilitator is not intending to instruct you on how to parent your children, but rather, partner with you in how best to support your children when their family situation changes.
